There are no restrictions on members should they wish to apply for the Simon Schot Grant each year, however only one application per member per year will be accepted.

All applications need to be received one (1) week before the AGM.

AGM each year. Receivers of the
Education Grants are announced
at the AGM, as well as listed in
the ATMS Journal and Wise 'n
Well e-newsletter. Winners are
generally required to pay for their
nominated course/activity and
provide a copy of the receipt to
ATMS for reimbursement.

Receivers are given six (6) months to redeem their Education Grant. Education Grants that are unclaimed will go to the funding of ATMS delivered continuing education activities for the benefit of all members.
